The show will be held May 4 & 5th, 2013 at 30352 Hwy 78, Santa Ysabel CA, 92070, This festival is open to the public and there is no charge to attend.

The mission of the festival is to educate and inspire the public through the combining of two ancient rhythms. The art forms of fiber art, and belly dance.

Sales, demonstrations, workshops, lectures, and belly dancing are all part of the festival.

No flea market type items are allowed and all booths must be related in some way to the fiber arts and handmade tribal or ethnic style belly dance items such as hand dyed skirts or silk veils, handmade tassels or hip belts etc.

Published times are Saturday, 10 a.m. to 4 p.m. and Sunday, 10 am to 4 p.m. Vendor check-in is from 7:30 to 9:30 a.m. on Saturday.

Vendors must be set up by 9:30 each morning. There is parking at the back of the Festival site. There is a short distance from the parking area to the booth site. Vendors must participate on both Saturday and Sunday for the published times of the show. Absolutely no early tear downs allowed.

Vendors are expected to bring in all display materials and shelving for their booth space. Booth size is approximately 10 ft x 10 ft. There are only 24 spaces available on a first come first serve basis. Any vendor selling on site will be charged \$50/10x10 booth, \$25.00/ 5x10 booth. A vendor may have a maximum of 2 booth spaces. Collection of CA sales tax is required (MUST HAVE CURRENT PERMIT).

Vendors are responsible for the security of all booth items. The Fiber/Dance Festival does not have security on Site overnight. The Festival is not responsible for items left on site overnight. Vendors are responsible for all items left after show hours on festival property. Participants are responsible for insuring their personal property and providing their own liability insurance.

The success of the festival lies with all participants. Your help getting the word out is very important. In addition to the show advertisement, vendors are asked to distribute flyers, and send out invitations via their Facebook and email accounts.

We reserve the right to control the number and quality of vendors.

Cancellations and Refund: The Fiber/Dance Festival has a **no refund** policy.

Any checks returned for non-payment are handled thru First Collections Inc.

Non-compliance with festival guidelines may result in vendor not being accepted back.
